




UCM provides a convenient online process for students using DualEnroll.com. Here's how to register:

First Time Students - Create an Account

You can register by computer or right on your smart phone by entering https://ucmo.dualenroll.com and clicking on **CREATE**MY ACCOUNT.

Complete the **New Student Registration** form to create your account. Provide all information including a login name and password of your choice. You must provide, either an email account, or cell phone number to create the account.



Your account is now ready for use, and you


can begin registering for courses.

Once you click **REGISTER**, you'll receive either a text message with an activation code or an email with a link to confirm your account. You <u>must</u> confirm your account before you can proceed with the registration. *If using email, be sure to check your junk and spam folders for the email.*

UCM has six application steps. Completed steps are shown in green and the current step is shown in orange. Use the hints included below to complete all required fields, then click the **update** button after each step.









Student Guide - Course Registration

If you've forgotten your username or password, we have you covered. You can retrieve your username and/or reset your password using the link on the login screen. You can also enter a Help Desk ticket by clicking the red Help Desk button in the upper right corner of the screen.





Register for Course(s):


While logged into your account, click on the **Courses** tab to review the list of courses available.

The course finder will show you only the courses available to you and your school. Use the filtering options on the left to narrow down your search.

Click on the course name to see class description and available sections. Select a section and click the **REGISTER** button to send in your course request.

Your part of the registration is done for now. You may choose to: **select another course**, **view registration status**, or **logout**. You will be notified when your registration is complete or if there's an issue.

Parents do not have accounts that allow them to log into the system; only students can log directly into DualEnroll.com. Once your student initiates the registration process, you will receive ongoing email and/or text notifications. The notifications will either provide you with an update on the status OR request consent to register for a given term.

Note: Sometimes email notifications are delivered to your JUNK or SPAM folder -check these folders for the notifications.
